NOTE: Students auditing classes pay regular tuition and fees.

Class and Registration Fees

Special services fee: 50¢ per credit is applied to **all** credits

Technology fee: \$5.00 per credit, not to exceed \$60.00

Facilities fee: \$17.50 minimum, and \$3.50 per credit after 5 credits, not to exceed \$35.00, is applied to **all** credits.

Class fees: see individual class listing in the schedule

**Non-Resident Waiver - U.S. citizens and INS-approved permanent residents are eligible for this waiver while establishing their Washington state residency.

Other and International - Visa classifications that are not eligible to establish residency, including international students.
